



#### ABSTRACT

#### **Objectives**

The study aimed to investigate the perception of community pharmacists about e-pharmacy in Osun State, Nigeria. The specific objectives were to determine the level of knowledge of e-

pharmacy among community pharmacists in Osun State, examine the attitude of the community pharmacists to e-pharmacy and identify the factors influencing their perception about epharmacy.

Methods

The study was a cross-sectional descriptive survey of community pharmacists. Primary data were obtained using a set of a pre-tested and validated semi-structured questionnaire consisting of three main sections in line with the study objectives. This was randomly administered to 82 community pharmacists. Descriptive and inferential statistics were employed in analysing the collected data at 5% level of significance with the aid of computer statistical package for social sciences (SPSS), Version 21.0.

Results

The results showed that a significant number (62.45%) of the respondents possessed knowledge of e-pharmacy and their attitude to e-pharmacy was positive (MWA = 3.09). Organisational factors, comprising business size, competitive strength and financial strength of the community pharmacy, were the only significant (p < .05) set of factors determining the perception of the community pharmacists about e-pharmacy.

Conclusion

Community pharmacists in Osun state possessed a fair knowledge of e-pharmacy and a positive attitude to the technology. With the possibility of adoption of this technology in community practice, regulatory agencies need to ensure up-to-date policy and legislation addressing its implementation while professional associations should organise training sessions such as seminars, workshops and conferences to educate community pharmacists more about epharmacy.
